Regular Meeting 6:00 P.M.
April 8, 2014

Present: Chairman Dan Worley, Vice-Chairman Larry Dost, Supervisor Woody Myers, and Secretary Valena Garlin. Township Engineer John Shambaugh and Solicitor Guy Beneventano were absent.

Chairman Worley called the meeting to order at 6:00 P.M. and led everyone present in the Pledge of Allegiance to the Flag.

Chairman Worley made a motion 1) to approve the Minutes from the March 10, 2014 meeting and 2) to approve the Treasurer's Report of March 31, 2014. The motion was seconded by Woody and carried unanimously.

POLICE REPORT –

Chief Mike Weigand gave the following report for the period of March 9 – April 7, 2014: There were 256 calls for service, 3,281 miles patrolled, 393 duty hours logged. There were 69 traffic citations issued and 23 warnings. The Department participated in 11 Buckle up details, 2 DUI patrols and 4 U.S. Marshal details.

Chief Weigand reminded the Board of the next Prescription Drug Take-Back scheduled for April 26, 2014 at Bermudian Springs High School.

The Make a Wish Truck Convey will be on May 4, 2014. The Adams County Police Memorial will be May 9, 2014 at the Oak Lawn Cemetery. National Night Out will be August 5, 2014 at the Latimore Township Park.

The next Crime Watch meeting will be held Thursday April 24, 2014 at 7:00 P.M. in the Latimore Township Building.

Larry Dost then made a motion seconded by Woody Myers to increase Mike's annual bonus from \$1,500 to \$2,000 for 2014. Motion carried by unanimous vote.

Bubba and Tom from the York Springs Fire Company and Ambulance were present. Tom stated they will start giving the township a monthly report. They now have 24/7 coverage for EMS. There were 7 calls in Latimore Township last month. Since this is the first year they will be paying for their own workers compensation, they are asking the municipalities for any additional financial help they could provide. Bubba gave the supervisors a breakdown list of services for the month. He also gave the supervisors the box cards to sign for the medic units that assist EMS. Tom stated they do not support the fire tax.

Dan said the township would like to be able to give more to the fire and ambulance companies but funds are limited. The township will have to use their funds to purchase and maintain their equipment as well as road projects on 4 roads. They are still trying to get things settled from the fire so an equipment shed can be built.
