Regular Meeting
February 11, 2019; 6:00 PM

REPORTS

Police Report: Chief Michael Weigand reported for 1/1/19-2/09/19 there were 336 total calls, 5,492 miles patrolled, 569.5 duty hours, 28 traffic citations, 50 warnings, 2 non-traffic citations, and 2 criminal arrests. The criminal arrests were for burglary and identity theft(fraud). He added that many of the warnings were for lights not being on during rainy conditions. He noted that the auto setting on your lights will not turn them on when they are necessary in these rainy conditions. You must manually turn them on. Chief Weigand also reported that at our last Drug Take-Back Day on October 24, 2018, Latimore Township placed 4/10 (in weight) in the county and 2/10 (in participants). The next Drug Take-Back Day will be on April 27, 2019 at Bermudian High School.
