**POLICE REPORT – Chief Michael E. Weigand**

**Chief Weigand** submitted the following report for the period April 9, 2012 - June 10, 2012: There were 338 calls for service, 7,915 miles patrolled and 759 duty-hours logged. There were totals of 116 traffic citations, 13 warnings and three (3) non-traffic citations consisting of two (2) criminal arrests and one (1) D.U.I arrests. The Department participated in two (2) D.U.I. patrols, three (3) U.S. Marshal details and two (2) Buckle Up details.

The Bike Rodeo was held Saturday, June 9, at Bermudian Springs High School. Chief Weigand estimated there were 65 participants.

National Night Out is scheduled for August 7, 2012 at Lake Meade. Activities are in the planning stages with some new items being added.
