Regular Meeting
June 13, 2016; 6:00 PM

Present: Chairman Daniel Worley, Vice-Chairman Larry Dost, Supervisor Woody Myers, Secretary Megan Colby, Solicitor Guy Beneventano, and Chief Michael Weigand. No visitors.

Chairman Daniel Worley called the regular meeting to order at 6:00 PM and led everyone present in the Pledge of Allegiance to the flag.

Dan Worley made a motion to approve the Minutes of the May 9, 2016, Regular Meeting and to approve the Treasurer's Report of May 31, 2016. Woody Myers seconded, and motion carried unanimously.

REPORTS

Police Report: Chief Michael E. Weigand gave the police report for May 8, 2016, through June 10, 2016. There were 219 calls for service, 2944 miles patrolled, 237.5 duty hours, 18 traffic citations, and 28 traffic warnings. Members of the police department also participated in a non-funded buckle-up detail, totaling an additional 10 hours.

Chief Weigand commented on the Drug Take-Back held at Bermudian Springs School District on April 30, 2016. It was the 8th take-back they had participated in, and, compared to the totals of September, 2015, they collected nearly double the amount of prescription drugs. The Adams County total of 1126 lbs of prescription drugs was more than double what it had been before.

Chief Weigand then informed the Board that it was time to renew the Agreement with Adams County Emergency Services for the Commonwealth Law Enforcement Assistance Network (CLEAN), which includes the use of the NCIC computer files. He recommended that the Board vote on this Agreement. Dan Worley then made a motion to approve the Agreement with Adams County Emergency Services. Larry Dost seconded, and motion carried unanimously.

Road Report: Woody Myers reported that all of the stone deliveries had been received and they were ready for Hammaker to come to do the roads. Dan Worley also mentioned that the road crew continues to do some coal patching.

Park Report: Woody Myers reported that the spring soccer season is over at the park.

Aiello Storm Water Management Agreement

Dan Worley made a motion to approve the Aiello Storm Water Management Agreement, and Larry Dost seconded. Motion carried unanimously. The Supervisors will sign the Agreement in the presence of a notary in the next few days.

Dan Worley announced that the Brent Tate Subdivision Plan would be tabled, as the Township Engineer is still waiting to receive some documentation for the Plan.

Police Personnel Changes

Dan Worley announced the hiring of a new part-time police officer, Derek Smith, and that Officer Joe Craven is no longer an employee of the Latimore Township Police Department. Officer Craven was unable to continue working in the Township due to other time commitments. However, Dan Worley assured those present that they were very pleased with Officer Craven and that they would welcome him back, should his circumstances change. Dan Worley then made a motion to appoint Derek Smith as a new part-time police officer. Woody Myers seconded, and motion carried unanimously.
