REPORTS

SUBDIVISIONS

The comments from Adams County Planning must be addressed and Engineer John Shambaugh will inform the township once all issues have been resolved. Motion carried by unanimous vote.

Secretary Valin Garlin said there are outstanding fees. Dan Worley stated all fees must be paid before the plan will be signed by the township supervisors.

All approved plans must be taken to Adams County Court House to be recorded. A signed recorded copy of each plan must be returned to the township office.

NEW BUSINESS

Larry Dost stated there was a budget workshop on October 28, 2014 to review the proposed budget. The supervisors felt the budget looked good with no increase in taxes needed. Dan Worley made a motion seconded by Larry Dost to advertise the budget that will be adopted at the December 8, 2014 meeting. Motion carried by unanimous vote.
