The next crime watch meeting will be October 23, 2014 at the township building at 7:00 pm. The police department received another Buckle Up Grant that will run from October 20 through October 24, 2014. It is a teen mobilization grant and they will be targeting teen seat belt usage. On October 25th there will be a 5K run through the township down in the borough area. This will be for the American Cancer Society. The Latimore Valley Old Timers will also have a tractor trot on a route throughout the township on October 25th that begins about 10:30 am. Chief Weigand recommended that the Board set Trick or Treat for October 25th from 6 PM to 8 PM to coincide with the time Lake Meade has Trick or Treat. Dan Worley made a motion to set Trick or Treat in the township for 6 to 8 PM on Saturday October 25, 2014. Woody seconded and motion carried by unanimous vote.
