Present: Chairman Daniel Worley, Vice-Chairman Larry Dost, Secretary Jennie Gordon. 1 visitor.

Chairman Dan Worley called the regular meeting to order at 6:00 PM and led everyone present in the Pledge of Allegiance to the flag.

Dan Worley made a motion to approve the Minutes of August 13, 2018 and to approve the Treasurer's Report of August 31, 2018. Larry Dost seconded, and motion carried.
